A Critter Crusader Crew is a group of two or more Critter Crusaders who work together to be kind, safe and responsible with animals.

Send Us Your Videos

If you would like to submit a video of yourself performing a Critter Cool talent or being FURR-ifically fun with your pet, record it on DVD (or CD) and send it to Animal Gambill. You may get a chance to produce your Tail-Waggin' Terrific Talent on the show! We may even put your video in our FURR-ific Photo and Video Gallery.

You and/or your Critter Crusader Crew can also submit a video (CD or DVD) of your Critter Crusader efforts or your special Critter Cool talent. If your class, club or organization would like to submit a FURR-ific educational skit about being kind, safe, or responsible with animals, feel free to have your teacher or group leader submit a video of your skit (along with signed guardian release forms of each child in video).

ALL videos must be submitted as MPG, AVI, or MOV on DVD or CD to be mailed via "snail-mail."

Ideas for Show and Newsletter Submissions:

- * Animal-related book reviews or movie reviews
- * Animal-related home videos - no more than 2 to 3 minutes long
- * Animal-related poetry and short stories
- * Animal-related news and educational information - please list resources of any factual information submitted
- * Animal-related product reviews based on first-hand (and first-paw) knowledge
- * Animal trivia questions for the game show segment of the show
- * FURR-ifically Funky animal facts

Ideas for Submissions (continued)

- * A question for Hobo Kitty or Riley to answer on the show or in the newsletter
- * Critter Cool pictures of your pets and a completed pet profile form (included in this document)
- * Stories about animal-related events you've attended

- * An image of your animal artwork (i.e., painting, drawing, sculpture, etc.)
- * Or any other creative idea you may want to submit – we may utilize your idea to help educate other Critter Crusaders

Submissions MUST be original. When providing factual information, please include sources (i.e. website, article, book, etc.)
